Call to order:

Chairman O'Hearn called the January 3, 2019 meeting of the Volunteer Committee to order at 6:00 P.M. in Conference Room A of the McFarland Municipal Center.

Volunteer Coordinator present: position vacant

1. **Review and possible approval of the Minutes of the June 7, 2018 Volunteer Committee meeting.**
Motion by Brost, seconded by Czebotar, and carried 4-0 to approve the minutes of the June 7, 2018 meeting.
2. **a. Business: Discuss Community Service Day 2019 tasks and framework.**
The 11th annual **McFarland Community Service Day is scheduled for April 20, 2019.** Committee members reviewed the timeline and assigned tasks. McFarland Bank will be hosting 'shredding' on April 20th. Sign-Up Genius will be reviewed and updated by Kathy Lyons, Brenda, and Lauren.

b. Business: Discuss promoting and involving the McFarland Chamber and other businesses including sponsorships.
Chairman O'Hearn suggested that the committee consider a community wide "Spring Celebration" to occur shortly after the Service Day morning tasks are completed. The committee discussed the feasibility of the idea and continued with suggestions for location, food and entertainment. It was recommended that local businesses would/could be involved by providing publicity and sponsorships. An ad hoc committee will investigate this concept further.
