1. **CALL TO ORDER, ROLL CALL.** President Jerry Mullen called the meeting to order at 8:12 a.m. Members present: Jerry Mullen, Jim McKay, Angela Wilcox and Carrie Nelson. Members excused: Vince Wagner. Staff Members Present: Police Chief Aaron Chapin.

3. **APPROVAL OF MINUTES.**

The eligible candidates will be listed in last name alphabetical order. President Jerry Mullen will prepare and send the list to Chief Chapin. Motion passed on unanimous vote.
