Village Board Minutes

1. CALL TO ORDER.

Village President Clow called the regular meeting of the McFarland Village Board to order at 5:35 pm in the Community Room of the McFarland Municipal Center.

1. Meredith Hughey residing at 5003 Wild Rye Court commented about Goal C from the Strategic Implementation Plan regarding Housing and Economic Development Plan. While she stated her general agreement with the goal itself, she had concerns about growth of the East Side where she resides and the specific action step to advance the East Side Plan as conceived within the Comprehensive Plan. She further stated that economic development is good but more information is needed from the developers in relation to the plans that are put forth.
