### **Meeting Minutes**

#### **1. CALL TO ORDER, ROLL CALL.**

- a. Meeting called to order at 6:00 p.m. by President Mullen. PFC Commissioners present: Jerry Mullen, Jim McKay, Angela Wilcox and Vince Wagner. PFC Commissioners excused: Lisa Becher.  
Staff Members present: Interim Police Chief Brian Redman, Fire & Rescue Chief Chris Dennis, and Police Sergeant Nate Jacobson.

#### **3. APPROVAL OF MINUTES.**

- a. Motion to approve the minutes of the June 4, 2025 meeting. Discussion and action regarding the minutes of the meeting. Call for changes or corrections. Hearing none, President Mullen called for a motion to accept the minutes as presented. Motion by Commissioner Wilcox and seconded by Commissioner McKay. Motion passed on a unanimous vote.

#### **4. BUSINESS.**

- a. Discussion and action on the Fire & Rescue Chief's request to reinstate Firefighter/Paramedic Daniel Drewes. After discussion, a motion was made by Commissioner Mullen and seconded by Commissioner Wilcox to authorize Chief Dennis to reinstate Daniel Drewes. Motion passed on a unanimous vote.
- b. Discussion and action on Interim Chief Redman's request to terminate the current eligibility list for Sergeant. A motion was made by Commissioner Wagner and seconded by Commissioner McKay to terminate the current Sergeant eligibility list effective June 25, 2025. Motion passed on a unanimous vote.

- c. Discussion and action on Interim Chief Redman's request to establish a process for the Sergeant position. A motion was made by Commissioner McKay and seconded by Commissioner Wilcox for Interim Chief Redman to proceed with the process as presented to the Commission. Motion passed on a unanimous vote.

#### **5. CLOSED SESSION:**

President Mullen will send a letter with the Commission's determination to Interim Chief Redman.
