PREVIOUS ACTION:

The Staff Submittal of the 2026 Budget was transmitted to the Village Board at their meeting on September 25, 2025.

The first budget review meeting was held on September 29, 2025 and covered a majority of the General Fund (100), Library Fund (210), and Canine Fund (800).

ISSUE SUMMARY:

The 2026 Budget as submitted by Village Staff was distributed to the Village Board for their review on September 25, 2025. An electronic version of the budget can be downloaded from the Village Website at www.mcfarland.wi.us/budget. You will need this electronic version or a paper copy within the budget binder as we begin our review at this meeting. Each of the reviews to be conducted in this meeting are listed on the agenda.

Changes since the budget's distribution will be presented and reviewed in the meeting as listed within the packet. Since the budget was distributed, there are no changes to report. As part of this first meeting, we will review the process for Village Board members to submit changes.

Whatever we do not finish in this meeting, we can defer for review to our next meeting for budget review.
